INTRODUCTION

Avoiding bribery, fraud, and corruption in international manufacturing and construction can be a formidable task. Because their global reputation is extremely important to them, ethical business practice is a deeply held core value for one of the world's leading suppliers of elevators and other mechanical conveyances. Performing accurate reviews and audits to measure compliance risks, and identifying and mitigating root causes, are considered mission-critical. When Genpact was retained by the organization's finance team to assist in handling PPO and T&E, they discovered the need for enhanced audit scope and coverage in order to meet the company's high standards of strict compliance and ethical business practices.

THE CHALLENGE

Genpact's client's annual spend was around \$40M, with roughly 8000 expense reports generated each month. Although they were using SAP Concur for T&E expense processing, the client was still relying on hard copy documents for their expense processing. All audits were manual and post-payment, with limited fraud and regulatory risk coverage. Over 20% of their employees operated in China and the high risk of fake or incorrect fapiao receipts was a key issue. Auditors were utilizing reviews of SAP Concur alerts and internal audit checklists for identifying threshold limits and delivering approvals. Without detailed reporting and tracking of non-compliance trends and patterns, there was a lack of visibility around high-risk spend and non-compliant employee behavior. And there was no formal process in place for addressing high-risk activities or their root causes.
